All services are individually focused and you are safe in this space to be true to yourself.

I do not support discrimination in any way including age, sex, orientation, gender, colour, disability, or medical status. Discernment however will be practised for conservation of wholeness.

All individuals retain both the absolute right and absolute responsibility to determine how they will live their lives including how they choose to protect their health.

As a professional I follow codes of conduct and practice. As an individual I am sovereign and free.

Respect of individual beliefs and choices will always be upheld.

I gracefully declare that no person will access these premises or services with the intention of manipulation, conflict, blame or abuse, or with any intention not in alignment with the highest good.

Covid-19 pre-screening

All reasonable steps have been taken to reduce the risks of transmission of COVID-19, however a level of risk will always remain.

If you are on the clinically extremely vulnerable or the clinically vulnerable list, we must ascertain that the benefits of attending an appointment outweigh any risks it might pose. The same applies to anyone you live with.

Having been made aware of these risks If you choose to attend an appointment this acts as confirmation that risks have been considered and outweighed by yourself.

I accept that is my personal responsibility to monitor my own health and I will not attend an appointment if:

- I have a cold, flu, Covid-19 symptoms or any contagious disease.
- I been exposed, diagnosed or suspected of having COVID-19 in the last 14 days
- I am isolating.
- A family member or close contact has CV 19 symptoms, a positive CV19 diagnosis or isolating.
- You, a family member, or close contact have travelled internationally in the last 15 days.

If you become unwell with COVID-19 symptoms on the day or your appointment, please DO NOT attend. No charge will be made for your missed appointment.
